Introduction

- This Report presents the Key Parameters and growth trends for the Telecom Services in India for the calender year 2018. To provide a broad perspective on the Telecom Services and to serve as a reference document for various stakeholders, research agencies and analysts. Chapter-1 depicts the growth pattern, in terms of Subscriber base and Tele-density of Wireline, Wireless, Internet and Value Added Services (VAS). Chapter-2 covers the key revenue and usage parameters of GSM, CDMA and Wireless Data services. Chapter-3 gives the financial and accounting data. The information relating to Cable TV, DTH & Radio Broadcast services is provided in Chapter-4.

CHAPTER 1

Subscription Data



- In this report, Tele-density is based on the population projections from census data published by the Office of Registrar General & Census Commissioner of India.
- The Report has been prepared based on the information furnished by the Service Providers.



Section A: Access Service — An overview



The number of telephone subscribers in India increased from 1,190.67 million at the end of Dec-17 to 1,197.87 million at the end of Dec-18, registering a yearly growth rate of 0.60%. However, the overall Teledensity in India declined from 91.90 at the end of Dec-17 to 91.45 at the end of Dec-18 at yearly decline rate of 0.49%.

2. Telephone subscription in Urban Areas declined from 688.25 million at the end of Dec-17 to 666.28 million at the end of Dec-18 at the yearly decline rate of 3.19%. Urban Teledensity also declined from 168.29 at the end of Dec-17 to 159.98 at the end of Dec-18 with yearly decline rate of 4.93%.

3. Rural telephone subscription increased from 502.42 million at the end of Dec-17 to 531.59 million at the end of Dec-18 at the yearly growth rate of 5.81%. Rural Teledensity also increased from 56.66 at the end of Dec-17 to 59.50 at the end of Dec-18 with yearly growth rate of 5.01%.



4. Out of the total telephone subscription, the shares of Rural telephone subscription increased from 42.20% at the end of Dec-17 to 44.36% at the end of Dec-18. However, share of Urban telephone subscription in total telephone subscription, declined from 57.80% at the end of Dec-17 to 55.64% at the end of Dec-18. The following chart depicts the rural-urban market share of telephone subscribers at the end of Dec-18.

Chart 1.3: Composition of Market Share – Wireless & Wireline Subscribers



M/s Reliance Jio Infocomm Ltd added maximum number of telephone subscribers (120.03 million net addition) during the year 2018.

M/s Vodafone & M/s Idea have been merged together during the year 2018 and became M/s Vodafone Idea Ltd.

- 10. Total Wireless (GSM+CDMA) subscriber base increased from 1,167.44 million at the end of Dec-17 to 1,176.00 million at the end of Dec-18, thereby showing a yearly growth rate of 0.73%. During the year 2018, net addition of 8.56 million wireless subscribers was recorded.
- 11. The Rural Wireless subscribers increased from 499.00 million at the end of Dec-17 to 528.48 million at the end of Dec-18 with yearly growth rate of 5.91%.
- 12. The urban wireless subscribers declined from 668.44 million at the end of Dec-17 to 647.52 million at the end of Dec-18 with yearly decline rate of 3.13%.



- 14. Overall Wireless Teledensity declined from 90.11 at the end of Dec-17 to 89.78 at the end of Dec-18. Rural wireless Teledensity increased from 56.28 to 59.15, however Urban wireless Teledensity declined from 163.44 to 155.48 at the end of Dec-18.
- 15. The share of rural wireless subscription increased from 42.74% at the end of Dec-17 to 44.94% at the end of Dec-18 and the share of urban wireless subscription declined from 57.26% to 55.06% during the same period.

Chart 1.5: Composition of Wireless Market Share – Rural & Urban Subscribers



After merger, M/s Vodafone Idea Ltd became the market leader with 35.61% market share of total wireless telephone subscription at the end of Dec-18 and M/s Bharti Airtel slipped at second position with 28.93% market share. During a short period of about two years, M/s Reliance Jio reached at third position with wireless market share of 23.82% at the end of Dec-18.
- 18. In term of net addition, M/s Reliance Jio Infocomm Ltd added maximum number of telephone subscribers of 120.03 million during the year 2018 and its yearly growth rate recorded as 75% during the year 2018.



Chart 1.7: Trend of Wireline Subscriber Base





Chart 1.8: Trend of Wireline Tele-density (rural-urban)







39. This section summarizes information submitted by 326 operators for the year ending 2018. Part-I consists of information of Internet service (both narrowband and broadband), Part-II consists of broadband service and Part-III covers narrowband service.

Part-I: Internet* Service (broadband* + narrowband^)

- 40. As per reports received from operators, total number of internet subscribers increased from 445.96 million at the end of Dec-17 to 604.21 million at the end of Dec-18 with yearly growth rate of 35.49%. Out of total 604.21 million internet subscribers, number of broadband subscribers is 525.36 million and number of narrowband subscribers is 78.86 million at the end of Dec-18.
- 41. Wireless Internet subscribers increased from 424.67 million at the end of Dec-17 to 582.79 million at the end of Dec-18 with yearly growth rate of 37.23%. Wired Internet subscribers increased from 21.28 million at the end of Dec-17 to 21.42 million at the end of Dec-18 with yearly growth rate of 0.66%.
- 42. Number of Broadband subscribers increased from 362.87 million at the end of Dec-17 to 525.36 million at the end of Dec-18 with yearly growth rate of 44.78%. However, the number of Narrowband subscribers declined from 83.09 million at the end of Dec-17 to 78.86 million at the end of Dec-18 with yearly decline rate of 5.09%.



Chart 1.12: Composition of Internet subscription as on 31st December, 2018








Chart 1.14: Subscriber base of top ten Service Providers (in million)


Chart 1.15 : Composition of Wired Internet subscribers as on 31st December, 2018







Chart 1.17: Technology** trend for Wireless Internet Access – Dec-18





Chart 1.2 : Market share of PSUs and Private Internet Service Providers









- 66. In wired broadband segment, BSNL holds 50.50% market share with 9.17 million subscribers followed by Bharti with 2.27 million subscribers at the end of Dec-18.
- 67. In wireless broadband segment, Reliance Jio holds 55.23% market share with 280.12 million subscribers followed by Vodafone Idea Ltd (21.27%) with 107.90 million subscribers at the end of Dec-18.
- 68. Top five service areas in respect of broadband subscriptions as on 31st December, 2018 are Maharashtra (44.24 million), Andhra Pradesh including Telengana (41.45 million), Tamil Nadu including Chennai (39.14 million), Karnataka (34.50 million) and Gujarat (34.40 million).

Chart 1.21: Composition of Broadband subscription – Technology wise










Chart 2.1: % Share of Prepaid Subscribers over total wireless subscribers

Chart 2.3: Quartery Trend of ARPU (₹) per month of Wireless Service












- As per information received from the wireless access service providers, number of wireless data subscribers has increased from 424.02 million at the year ending 2017 to 578.20 million at the year ending 2018 with yearly growth rate of 36.36%. The number of wireless data subscribers was 227.91 million at the year ending 2013.
- 2. Total number of wireless telephone subscribers was 1176.00 million at the year ending 2018. Out of total number of wireless telephone subscribers, the number of wireless data subscriber was 578.20 million at the year ending 2018. Thereby, share of wireless data subscribers was 49.17% of total wireless telephone subscribers the year ending 2018.

- 3. Total volume of wireless data usage increased from 20,092 million GB during the year 2017 to 46,404 million GB during the year 2018 with yearly growth of 131%.



- 5. 4G technology (LTE Long Term Technology) was introduced in India during the year 2016. During a short period of time, 4G data technology became the market leader in wireless data usage with total volume of 40,304 million GB during the year 2018.
- 6. Out of total volume of wireless data usage of 46,404 million GB in the year 2018, 4G (LTE) technology has the major part of 86.85% with volume of 40,304 million GB. Shares of 2G, 3G and CDMA data usage are 0.95%, 12.18% and 0.01% respectively in total volume of wireless data usage in the year 2018.
- 7. There has been a very sharp decline in CDMA data subscribers and data usage due to verge of closure of CDMA technology by the service providers. The number of customers availing data services from CDMA service providers are less than 0.01% of the total mobile customers during the year 2018.

- 10. Total volume of wireless data usage increased by 131% in the year 2018 over previous year, as compared to the yearly growth rate of 233% in the year 2017. However, the growth rate in volume of wireless data usage were recorded 66% and 238% in the years 2015 and 2016 respectively over previous year.
- 11. Total revenue from wireless data usage increased from ₹38,882 crore in the year 2017 to ₹54,671 crore in the year 2018 with yearly growth rate of 40.61%. The total revenue from wireless data usages was ₹22,265 crore in the year 2014.







- 17. Average wireless data cost to subscriber has been calculated in respect of total wireless data revenue and volume of total wireless data usage reported by the access service providers.
- 18. The average cost to subscriber for wireless data in the year 2014 was ₹ 269 per GB and in the year 2015, it was ₹ 226 per GB. On introduction of 4G (LTE) technology in India, average cost to subscriber for wireless data usage sharply declined to ₹ 75.57 per GB during the year 2016. Further, average cost to subscriber for wireless data declined from ₹ 19.35 per GB in the year 2017 to ₹ 11.78 per GB in the year 2018.
- 19. Average cost to subscriber of GSM data shows declining trend over the last four years and it declined from ₹ 289 per GB in the year 2014 to ₹ 11.78 per GB in the year 2018. CDMA data cost to subscriber shows mixed trend during the same period. However, average cost to subscriber for overall wireless data service shows declining trend over the period.

21. Declining trend of cost of data to subscriber shows intense market competition in data services in the telecom market. This has led to a situation where even a person living below poverty line can easily afford mobile data service and avail various kinds of Government and commercial services. This has facilitated the financial inclusion of the masses living on the fringe. Accordingly, the Authority has continued with its policy of 'forbearance' in the Telecom Tariff.

- 1. Gross Revenue (GR) declined from ₹2,55,655 crore in the year 2017 to ₹2,37,417 crore in the year 2018 with yearly decline rate of 7.13%. Adjusted Gross Revenue (AGR) also declined from ₹1,60,814 crore in the year 2017 to ₹1,44,446 crore in the year 2018 with yearly decline rate of 10.18%.
- Pass through charges declined by 1.97% from ₹94,841 crore in the year 2017 to ₹92,971 crore in the year 2018. Pass-through charges as a percentage of Gross Revenue are 39.16% in 2018 as against 37.10% in the previous year.





6. Access services contributed 71.19% of the total Adjusted Gross Revenue of telecom services. In Access services, Gross Revenue (GR), Adjusted Gross Revenue (AGR), License Fee and Spectrum Usage Charges (SUC) declined by 8.88%, 16.13%, 16.20% and 17.82% respectively in the year 2018 over the year 2017. However, Pass Through Charges increased by 5.66% during the same period.

Chart 4.3: Composition of Adjusted Gross Revenue (in crore ₹) of Access Service Providers for the year 2018





Chart 4.4: Composition of Public/Private sector of Adjusted Gross Revenue (Access Service) (in crore ₹)





A. Satellite TV Channels

1. A total of 880 private satellite TV channels have been permitted by the Ministry of Information and Broadcasting (MIB) for uplinking only/downlinking/uplinking, as on 31st December, 2018.

B. PayTV Channels

- 2. Telecom Regulatory Authority of India (TRAI), in March, 2017, notified the new regulatory framework for Broadcasting and Cable services. The framework comprises of Tariff Order 2017, Interconnection Regulations 2017 and Quality of Service & Consumer Protection Regulations 2017. The framework was duly notified vide press release no.71/2018 dated 3rd July 2018 with revised timelines for implementation. All the timelines prescribed in the above-mentioned framework commenced from 3rd July 2018. The new regulatory framework has come into effect on 29th December 2018.
- 3. As per the Telecommunication (Broadcasting and Cable) Services (Eighth) (Addressable Systems) Tariff Order, 2017 dated 3rd March 2017, every broadcaster has to offer all its channels on a-la-carte basis to all distributors of television channels and declare maximum retail price, per month, payable by a subscriber for each of its pay channel offered on a-la-carte basis. Further, it is also permissible for a broadcaster to offer its pay channels in the form of bouquet and declare the maximum retail price, per month, of such bouquet payable by a subscriber.
- 4. As per the reporting done by broadcaster in pursuance of the Tariff Order dated 3rd March 2017, there are 330 pay channels, as on 31st December 2018, which include 231 SD pay TV channels and 99 HD Pay TV channels. A list of Maximum Retail Prices (MRP) of pay channels offered by broadcasters for subscribers as reported to TRAI is attached as Annexure-5.1.

C. Cable TV Sector


5. Digitization, with addressability, of cable TV sector has been completed. The country achieved 100% digitization of Cable TV network. This is a stupendous achievement making India as the only large country where 100% digital cable has been achieved through mandatory regulations.

D. Direct-to-Home (DTH) Sector

- 6. Since its introduction in the year 2003, Indian DTH service has displayed a phenomenal growth. During the quarter ending 31st December, 2018, there were 5 pay DTH service providers in India. M/s Videocon D2h has been merged with M/s Dish TV during the year 2018. List and details of pay DTH service providers is placed at Annexure-5.2.
- 7. DTH has attained net pay active subscriber base of around 70.49 million with 5 pay DTH service providers as on 31st December, 2018 as compared to 67.56 million subscribers with 6 pay DTH service providers as on 31st December, 2017. This is in addition to the subscribers of the free DTH services of Doordarshan. Yearly growth rate of 4.34% has been recorded in pay active subscriber base in the year 2018 as compared to the previous year.
- 8. The following chart depict the yearly trend of number of pay active subscsribers of pay DTH service during last four years.




Chart 5.2: Trend of Net Active subscribers (in million) of pay DTH service

Chart 5.3: Composition of market share in respect of Net Active subscriber base of Pay DTH Service Providers





- 11. Apart from the radio Stations operated by All India Radio, the public broadcaster, as on 31st December 2018, there are 355 operational private FM Radio stations in 97 cities with operational 33 Private FM Radio broadcaster as compared to 326 operational private FM Radio stations in 86 existing cities with operational 34 FM Radio broadcaster as on 31st December 2017.


