The details of eligibility criteria and experience etc., are given as under:-

Pay Level:	Pay Level-11 in the Pay Matrix under 7 <sup>th</sup> CPC  [Pre-revised PB-3, Rs. 15600-39100+ GP Rs. 6600] with allowances such as DA, HRA etc. as per Govt. Rules.
Eligibility criteria:	Officers of the Central Government, Central Public Sector Undertakings and Statutory and Autonomous Bodies:  (i) Holding equivalent post on regular basis <u>OR</u> (ii) Officers in Junior Time Scale with 4 years of regular service in that grade <u>OR</u> 7 years of regular service in the grade of Section Officer <u>OR</u> any other equivalent <u>OR</u> higher grade. The officer must possess the working knowledge of computer.
Qualification:	Essential: A Master's/ Bachelor's Degree in Business Administration/ Economics/ Commerce/ Engineering/ Law/ Science/ Humanities from a recognized University/ institution or, Membership of the Institute of Chartered Accountants of India/ Institute of Cost and Works Accountants of India and possessing requisite experience in the relevant field.  Desirable: Preference will be given to officers having wide experience in implementing Information Technology systems.

- 3. The appointment will be made on deputation on foreign service terms and will be governed by the instructions issued by the DoP&Trg. OM No. 6/8/2009-Estt. (Pay II) dated 17<sup>th</sup> June, 2010, as amended from time to time. The maximum age for appointment on deputation shall in no case exceed 56 years on the date of closing of applications in TRAI.
- 4. All the Ministries/Departments, Central Public Sector Undertakings and Statutory and Autonomous Bodies are requested to forward applications in the prescribed proforma (can be downloaded from TRAI's website www.trai.gov.in) along with attested copies of ACRs/APARs for the last five years and vigilance/disciplinary clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately in the event of their selection. The application should be sent in an envelope superscribing the post applied for to the Deputy Advisor (H.R.), Telecom Regulatory Authority of India, Mahanagar Door Sanchar Bhawan, J.L.
