

The undersigned on behalf of the Telecom Regulatory Authority of India (TRAI) is directed to invite sealed Open Tender Enquiry (OTE) for supply of various grocery items like tea/coffee, milk powder, sugar cubes, tea bags, juice and biscuits etc. for official use in the TRAI, New Delhi as detailed in scheduled of rates at ANNEXURE – I and terms & condition given below:

Terms and Conditions of OTE

- OTE must be in the form furnished by TRAI and should be free from corrections/erasures. In case there is any unavoidable correction it should be properly attested. If not, the Tender will not be considered. Tender written in pencil will not be considered.
- OTE duly completed in all respect must reach the designated address up to 1500 hrs. on Tuesday the 07/05/2019 positively. OTE received after 1500 hrs. on 07/05/2019 will not be considered. OTE will be opened on same day at 15:30 hrs. in TRAI office by a duly constituted committee, in presence of the tenderers or their authorized representatives who may wish to be present. [In case opening date is declared as holiday by the Government then the same will be opened on next working day at same time and venue]. Tenders shall be submitted in person only. Tenders submitted by Telegram/Fax/courier etc. will not be considered.
- 3. Bidders may quote their maximum %age discount on Maximum Retail Price (MRP). This % age of discount shall remain in force during the currency of the contract. It may specifically be noted that no change in the rates offered would be allowed except when the change occurs on the MRP of the item during the currency of the contract as mentioned in the point (5) below.
- 4. The successful bidder will submit revised MRP of the items (in writing) whenever any change is occurring on the MRP of the item to TRAI for revision of rate. Payment shall be made after considering the quoted discount for that items. However, the rate of discount offered finalized on each item will not be changed during the whole contract period.
- 5. Bidders will be required to quote their rates as per the schedule of rates as given in Annexure-I. L-1 will be decided on the basis of an overall cost on the basis of quantity indicated by TRAI in the SOR multiplied by the rate quoted by the firm. The rate must be quoted inclusive of all taxes.



- TRAI reserves the right to accept the offer by individual items and reject any or all tenders without assigning any reason there of and does not bind itself to accept lowest quotations.
- 7. A complete set of Tender Documents may be downloaded from TRAI website i.e. http://www.trai.gov.in/content/Tender.aspx and also From CPP Portal. In case the prospective bidders need any clarification regarding any terms and conditions of the bid document, the bidder may seek clarification from the undersigned in person or telephonically before the last date of submission of tender.
- Manufacture's name and country of origin of materials offered must be clearly specified. Please quote whether your firm is large scale industry. If you have NSIC/ MSE/ MSI/ DGS&D Certificate, please attach it to the quotation. Mention your registration details.
- 9. At the initial stage, the contract shall be awarded for a period of two years from date of submission of security deposit amount. TRAI will have discretion for extending it for further term of one or more year on mutually acceptable terms and conditions. However, a formal agreement between TRAI and successful bidder is to be signed separately.
- Complete details and ISI specification if any must accompany the quotation. Make/brand of the item shall be stated wherever applicable.
- Proof of registration for GST number shall be attached. A selfcertificate shall be given in case the tenderer is not covered under GST.
- 12. All supplies are subject to inspection and approval before acceptance. Manufacturer/supplier warranty certificate and manufacturer/ Government approved lab test certificates shall be furnished along with the supply, wherever applicable.
- 13. The TRAI, New Delhi shall be free to test the sample of various items supplied by the supplier from any independent source for which all required cooperation/documentation shall be submitted by the suppliers.
- 14. The bidder shall ensure supply of items not later than Two month of manufacturing date. The TRAI, New Delhi also entitled to receive latest packing with all scheme relating free/gift/extra quantity items as may be available in the market upon such items.
- 15. The firm also ensure that supply items should be with the same brand/company as mentioned in the schedule, however, in case it is not available in market alternate brand shall be got approved from TRAI, New Delhi TRAI decision in this regard shall be final and bounding.

- 16. TRAI reserves the right to modify the quantity specified in this enquiry.
- 17. The prices quoted should be firm till the supplies are completed. Please quote the rates in words and figures. Rates quoted should be free delivery at destination including all charges otherwise the OTEis likely to be rejected. If there is no indication regarding the FOR, in the quotation, then it will be considered as FOR destinations.
- 18. The successful bidder would be required to supply the required items to the TRAI Office, New Delhi at his own cost. In case TRAI office will shift from present location to another location, within NCR supply will be made by vendor at new location. The firm supply required items on very short notice as and when required and within (03) three days from the date of issue of the order in normal course of delivery.
- 19. Demand Draft/Pay order of Rs. 15,000/- [Rs. Fifteen thousand only] towards Earnest Money Deposit (EMD) in favour of 'TRAI', payable at "New Delhi" should also be attached wherever applicable with the bid document by the bidder which will be released after completion of tender process. No interest will be payable on the EMD.
- 20. The successful Tenderer whose rates are finally accepted must deposit an amount of 10% of the contract value of 12 months as Security Deposit/Performance Guarantee within 15 days from the of issue of work order. PBG should remain valid for period of 60 days beyond the date of completion of the contract.
- 21. Formal Agreement with the successful bidder will be signed after deposit of Security Deposit/Performance Guarantee. If the Tenderer fails to observe or comply with the said stipulation, the amount of earnest money shall liable to be forfeited.
- No interest will be payable on the security deposit and the security deposit will be returned only after successful completion of the contract period.
- 23. TRAI reserve the right to recover any loss sustained due to delayed delivery by way of penalty. Failure to supply the material within the stipulated period shall entitle TRAI to impose penalty @ ½% (half percent) of the total value of the item covered in order as penalty per day subject to a maximum of 5% (five percent) unless extension is obtained in writing from the office on valid ground before expiry of delivery period.
- 24. If the deliveries are not maintained and due to that account TRAI is forced to buy the material at your risk and cost from elsewhere, the loss or damage that may be sustained thereby, will be recovered from security deposit of the defaulting supplier. Supply of poor-quality products would liable to forfeiting of Security deposit.
- 25. No advance payment will be made in any case. Payment of Bill shall be made after receipt the items at the prices approved by the TRAI, if found in order. In case of any complaint of non-fulfilment or any obligation under the contract, the TRAI reserves the right to deduct the payment due from the firm from monthly bill (s). The payment shall be made through RTGS/NEFT. TDS and all other taxes will be deducted as per applicable lows time to time.

- 27. The firm blacklisted at any point of time by any Ministry/Department need not apply. In case the fact is concealed, and it will come to the notice of the TRAI, during the period of contract, the contract shall be terminated straightway, and the security deposit will be forfeited. If the fact comes to notice before award of contract, his bid shall be rejected outright & tender may be awarded to L2 bidder. A declaration to the effect that the tenderer has not been blacklisted by Central/State Govt. Public Sector Units or its contracts have not been terminated on account of poor performance during last 3 years as per Annexure-II.
- 27 The tenderer will be required to keep the offer open for a period of 90 (Ninety) days from the last date of submission of tender.
- 28. In the event to any dispute arising between TRAI and the firm in any matter or arising directly or indirectly, the matter shall be referred to the Advisor (A), TRAI who may himself act as sole arbitrator or may nominate an officer of TRAI as sole arbitrator, notwithstanding the fact that such officer has been directly or indirectly associated with the contract. The firm will not be entitled to raise any objection for the appointment of such officer of TRAI as the sole arbitrator. The award of the arbitrator shall be final and binding on both the parties to the agreement subject to provisions of Arbitration and Conciliation Act, 1996 and rules made there under. The parties expressly agree that the arbitration proceedings shall be held at New Delhi. The language of arbitration shall be in English only.
