Dear Sir,

This is with reference to the above-mentioned letter, wherein we have been requested to do the needful action and furnish our response on the issues raised by M/s RJIO.

At the outset, we completely deny that there has been any delay in allocation of Pols, even though RJIO services remain under test conditions. Idea Cellular has always provided utmost support to RJIO on their requirements.

At the initial stage itself, we had provided RJIO with 85 E1s across all Circles, and in the period April-July 2016, additional 205 E1s have been augmented and 38 more E1s are in process of augmentation across all circles to support RJIO test traffic.

In this regard, our response sent to RJIO is enclosed for your reference. The response includes the details of Pol augmentation provided till date.

IDEA is continuing to fully support RJIO and we have accordingly instructed our Circle teams to augment further E1s on the basis of traffic congestion as per the agreement clauses.

We trust the above clarifies your query.

Dear Sir,

This is with reference to your letters regarding Augmentation of Pols for access & NLD services.

We are surprised by your letter, since Idea Cellular has always provided utmost support on your requirements. We completely deny that there has been any delay in allocation of Pols, even though your services remain under test conditions. In this regard, kindly note the following :

1. IDEA Cellular has supported RJIO for Initial POIs as demanded for the Test trial purposes since November 2014, although there are no norms under our interconnect agreement for test traffic. We have not observed any congestion on initial links till around February/ March of 2016 and neither did RJIO sent any communication or demand regarding the same. Thus, the POIs were commissioned since November 2014 and for more than a Year there was very less Traffic on POIs commissioned with RJIO.
2. You would kindly acknowledge that at initial stage itself, we had provided RJIO with 85 E1s across all Circles, and **in the period April-July 2016, additional 205 E1s have been augmented and 38 more E1s are in process of augmentation across all circles** to support RJIO test traffic.
3. As per interconnect agreement, augmentation commences at 70% utilisation with defined process and we are working with RJIO teams across 22 circles for the same on regular basis. To support RJIO TEST TRAFFIC originated from RJIO TEST connections, IDEA is already providing the necessary augmentation in all circles. **Details of current EIs and augmentation details provided till date enclosed as Annexure 1.**
4. As per the agreement terms, RJIO is supposed to give clear forecast at least 6 months in advance, for which RJIO has provided random bulk requirement on 7th April 2016 and subsequently, the calculated / estimated POIs requirement has been received by us only 21st June 2016. We do not agree with this forecast requirement, since the entire traffic generation is imbalanced and based on free offerings in test environment. Thus the traffic forecast may undergo change post commercial launch.
5. You may kindly note that the traffic being handed over to us completely disproportionate to test usage environment and leading to choking of Pols.

In spite of the above and even though RJIO has still not communicated any expected Launch date to start commercial Subscriber traffic on these POIs, IDEA is continuing to fully support RJIO and we have accordingly instructed our Circle teams to augment further E1s on the basis of traffic congestion as per the agreement clauses.

We trust the above clarifies the issues raised in your letter.
