


- Mobile Number Portability requests increased from 54.33 million subscribers at the end of June 2012 to 59.31 million at the end of July 2012. In the month of July 2012 alone, 4.98 million requests have been made for MNP.
- Active wireless subscribers on the date of Peak VLR in July 2012 are 698.06 Million, 76.42% of the total subscribers.
- Broadband subscription reached 14.68 million in July 2012 from 14.50 million in June 2012.


# I. <u>Total Telephone Subscribers</u>

The number of telephone • in India subscribers decreased to 944.81 million at the end of July, 2012 from 965.52 million at the end of June 2012, thereby registering a monthly growth rate of -2.14%. The share of urban subscribers has declined to 63.83% from 64.40% whereas share of rural subscribers has increased to 36.17% in the month of July 2012. With this, the overall Teledensity in India reached 77.79 at the end of July, 2012 from 79.58 of the previous month.





Subscription in urban areas decreased from 621.76 million in June, 2012 to 603.03 million at the end of July, 2012. Subscription in rural areas decreased from 343.76 million to 341.79 million during the same period. The monthly growth rate of urban and rural subscription is -3.01% and -0.57% respectively. The overall urban Teledensity has decreased from 169.03 to 163.66 and Teledensity decreased from Rural 40.66 to 40.40.






### II. Wireless Segment (GSM, CDMA & FWP)


wireless subscriber Total base decreased from 934.09 million in June 2012 to 913.49 million at the end of July 2012, registering a monthly growth of -2.21%. This decline is due to large scale disconnections by some of the service providers. The share of wireless subscribers urban has decreased from 63.98 % to 63.37% where as share of rural wireless subscribers increased has from 36.63%. 36.02% The overall to wireless Teledensity in India reached 75.21.





• Wireless subscription in urban areas decreased from 597.59 million in June 2012 to 578.90 million at the end of July 2012. The wireless subscription in rural areas decreased from 336.51 million to 334.58 million during the same period. The urban wireless Teledensity has decreased from 162.46 to 157.11 and rural Teledensity has decreased from 39.80 to 39.54. Detailed statistics is at Annexure I.

Private operators hold 88.60% of the wireless market share (based on subscriber base) where as BSNL and MTNL, the two PSU operators hold only 11.40% market share. The graphical presentations of market shares and shares in net additions of all the service providers during the month of July, 2012 are given below:




A. Service Provider wise Market Share as on 31<sup>st</sup> July, 2012.

### III. VLR Data


Out of the total 913.49 million wireless subscribers, 698.06\* million were active on the date of Peak VLR for the month of July 2012. The proportion of VLR subscribers is approximately 76.42% of the total wireless subscriber base reported by the service providers.

Circle-wise, J&K has the highest proportion of VLR subscribers with 83.72% followed by Maharshtra (82.31%) and Madhya Pradesh (81.78%); Tamil Nadu has the lowest proportion with 67.82%. Service Provider wise, Idea leads the tally with 92.80% followed by Bharti (90.46%). The detailed statistics of proportionate VLR is at Annexure II & methodology used for reporting subscriber base/active subscribers is at Annexure IV.


# IV. Mobile Number Portability

As per the data reported by the service providers, by the end of July 2012 about 59.31 million subscribers have submitted their requests to different service providers for porting their mobile number. In MNP Zone-I (Northern & Western India) maximum number of requests have been received in Rajasthan (5.63 million) followed by Gujarat (5.34 million) whereas in MNP Zone-II (Southern & Eastern) maximum number of requests have been received in Karnataka (7.19 million) followed by Andhra Pradesh Service area (5.72 million). In the month of July 2012, total number of subscribers who have submitted their request for MNP is 4.98 million. The status of MNP requests in various service areas is given below:


# v. <u>Wireline Segment</u>

Wireline subscriber base declined from 31.43 million at the end of June 2012 to 31.33 Million at the end of July 2012. Net reduction in wireline subscriber base was 1.01 lakhs. The share of urban subscribers has increased from 76.92% to 77.01% where as share of rural subscribers has declined from 23.08% to 22.99%. The overall wireline Teledensity has marginally decreased from 2.59 in June 2012 to 2.58 in July 2012, with urban and rural Teledensity being 6.55 and 0.85 respectively. BSNL and MTNL, the two PSU operators hold 80.02% of the Wireline market share. Detailed statistics is at Annexure-III. The graphical presentation of market share of all service providers as on 31<sup>st</sup> July 2012 is given below:

# VI. <u>Category wise Growth</u>

• As can be seen from the following tables, while the Circles in Category B show the highest reduction in subscriber base, the Circles in Category Metro show the highest rate of decline in the wireless sector from June 2012 to July 2012. In wireline segment, the Circles in Category B have shown the highest reduction in subscriber base and highest monthly rate of reduction.



## VII. <u>Broadband (≥ 256 Kbps download)</u>

Total Broadband subscriber base has increased from 14.50 million at the end of June 2012 to 14.68 million at the end of July 2012, there by showing a monthly growth of 1.20%. Yearly growth in broadband subscribers is 17.40% during the last one year (August 2011 to July 2012).

As on 31<sup>st</sup> July 2012, there are 156 Internet Service Providers (ISPs) which are providing broadband services in the country. Out of this only 114 ISPs have provided data for the month of July 2012, for the rest of the ISPs data from previous month has been retained (Data from top 10 ISPs, which constitute 93.60% of the total subscriber base, have been received for the month of July 2012). Top five ISPs in terms of market share (based on subscriber base) are: BSNL (9.36 million), Bharti Airtel (1.37 million), MTNL (1.08 million), You Broadband (0.66 million) and Hathway (0.37 million).

# VLR Subscribers in the Wireless Segment

**Home Location Register (HLR)** is a central database that contains details of each mobile phone subscriber that is authorized to use the GSM core network. The HLRs store details of every SIM card issued by the mobile phone operator. Each SIM has a unique identifier called an International Mobile Subscriber Identity (IMSI), which is the primary key to each HLR record. The HLR data is stored for as long as a subscriber remains with the mobile phone operator. HLR also manages the mobility of subscribers by means of updating their position in administrative areas. It sends the subscriber data to a Visitor Location Register (VLR).

**Subscriber numbers** reported by the service providers is the difference between the numbers of IMSI registered in service provider's Home Location Register(HLR) and sum of other figures as given below:-

**Visitor Location Register** (VLR) is a temporary database of the subscribers who have roamed into the particular area, which it serves. Each base station in the network is served by exactly one VLR; hence a subscriber cannot be present in more than one VLR at a time.

If subscriber is in active stage i.e. he is able to send/receive calls/SMSs he is available both in HLR and VLR. However, it may be possible that the subscriber is registered in HLR but not in VLR due to the reason that he is either switched-off or moved out of coverage area, not reachable etc. In such circumstances he will be available in HLR but not in VLR. This causes difference between subscriber number reported by the service providers and numbers available in VLR.

The VLR data calculated here is on the basis of active subscribers in VLR on the date of Peak VLR of the particular month for which the data is being collected. This data is to be taken from the switches having the purge time of not more than 72 hours.
