
Telecom Regulatory Authority of India (TRAI), New Delhi is a statutory body set up under an Act of Parliament viz. TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The organization invites application for the following post for appointment on deputation on foreign service basis initially for a period of two years. The details of qualification and experience etc., are as under:-

Officers of the Central Govt., Public Sector Undertakings and Statutory and Autonomous Bodies (i) holding equivalent post on regular basis or (ii) six years of regular service in the grade of Assistant in PB-2 Rs. 9300-34800 plus GP Rs. 4200 (pre-revised scale of pay of Rs.5500-9000) or equivalent; (iii) Working knowledge of computer; (iv) Must possess adequate experience in translation from English to Hindi and vice-versa; (v) Preference will be given to officers having experience of translation in scientific and technical department.

3. TRAI has been exempted from the rule of immediate absorption for the post of Section Officer for a period of three years with effect from 24.05.2010.
