2. The Appointing Authority may, from time to time, by appropriate order, appoint on permanent absorption basis any person already appointed on deputation in the Authority in accordance with provisions contained in TRAI Appointment Regulations.

3. TRAI has been exempted from the rule of immediate absorption upto 23.01.2011 by Department of Pension and Pensioner's Welfare for appointment on deputation. However, TRAI has taken up the matter with the Government for exemption from the applicability of the rule of immediate absorption for all posts in TRAI.
