**Sub:- Calling applications for filling up of various posts on deputation on foreign service terms.**

Reference is invited to Telecom Regulatory Authority of India (TRAI), New Delhi circular of even number dated 6.4.2011 and 9.5.2011 calling for applications for filling up of various posts on deputation on foreign service terms initially for a period of two years. The details of qualification and experience etc. are reproduced as under:

2.	Senior Research Officer	Rs.15600-39100 + grade pay Rs.6600/- (plus allowances such as DA, HRA, etc as per Govt Rules.)	Officers of the Central Govt., Public Sector Undertakings and Statutory and Autonomous Bodies (i) holding equivalent post on regular basis or (ii) Officers in Junior Time Scale with 4 years of regular service in that grade or 7 years of regular service in the grade of Section Officer or any other equivalent or higher grade. The officer must possess the working knowledge of computer. <u>Essential Qualification for (Sr No. 1 &amp; 2):-</u> A Master/Bachelor's Degree in Business Administration / Economics/ Commerce/ Engineering/ Law/ Science/ Humanities from a recognized University/ Institution or, Membership of the Institute of Chartered Accountants of India/ Institute of Cost and Works Accountants of India and possessing requisite experience in the relevant field.  Note:- The vacant posts of Deputy Advisor include the posts in Legal Division, Economic Regulation Division and Broadcasting and Cable Services Divisions also. Person with appropriate qualification and experience in these areas will be given preference while filling up the vacant posts.  Age:- Not exceeding 56 years on the date of closing of applications.

2. Officers of the Central Govt., Public Sector Undertakings and Statutory and Autonomous Bodies (i) holding equivalent post on regular basis or (ii) officers in twelve years of regular service in Group A of which at least four years of regular service shall be in the Junior Administrative Grade and possessing essential qualifications shall be considered for appointment as Joint Advisor in the Pay Band - 4 of Rs. 37400 - 67000 + GP Rs. 8700.
3. The last date for receipt of applications is now extended upto 27<sup>th</sup> June 2011.
4. The posts of Deputy Advisor/Joint Advisor have been exempted upto 23.1.2016 and the posts of SRO have been exempted upto 23.5.2013 from the rule of immediate absorption by Department of Pension & Pensioners Welfare for appointment of central govt., servants on deputation.
5. All the Ministries/Departments, Public Sector Undertakings and Statutory and Autonomous Bodies are requested to forward applications in the enclosed proforma (can also be downloaded from TRAI website [www.trai.gov.in](http://www.trai.gov.in)) alongwith attested copies of ACRs for the last five years and vigilance/disciplinary clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately in the event of their selection.
